There are no transfers to third countries.

The processing does not involve the activation of an automated decision-making process and the data collected will be processed lawfully, as:

1. GDPR - Article 6 Paragraph 1, A) the interested party has given consent to the processing of their personal data for one or more specific purposes
2. GDPR - Article 6 Paragraph 1, B) the processing is necessary for the execution of a contract of which the interested party is a party or for the execution of pre-contractual measures adopted at the request of the same

You can, at any time, exercise the rights:

- to the portability of data (in the cases provided for by the legislation);
- to revoke the consent, where provided: the revocation of the consent does not affect the lawfulness of the processing based on the consent given before the revocation;
- to lodge a complaint with the supervisory authority (Privacy Guarantor) to give a mandate to a body, organization or non-profit association to exercise its rights, to request compensation for damages resulting from the violation of the law ( art. 82.)
